RE: Planned Giving Report for Q4 of 2018

The attached reports outline the development activities and results of the Gift Planning program as carried out by Lutheran Foundation Canada throughout the fourth quarter of 2018. For reference, the following categories have been used to define the types of gifts being reported:

Direct Gift - a lifetime gift received, often by way of transferred shares, but also by cash or cheque

Bequest Gift - a gift received from an estate settlement

Deferred Gift Established - a planned, future estate gift directly attributable to the work of a Foundation Gift Coordinator

Deferred Gift Identified - a previously planned, future estate gift, of which a Gift Coordinator has been notified

Included for your information are the following:

Page 1 is the **Activity Output Report Q4 2018**, which indicates the total value of gifts as either received, established or identified each month. The upper table compares budgeted and actual amounts for each gift type within each district by month, whereas the lower table shows anticipated and actual amounts allocated to each organization, **as stipulated by the donors**. The Budget amounts for organizations shown in the lower table are based upon historical information only. The Gift Coordinators work on behalf of all LCC organizations and congregations equally, encouraging donors to give where their passions lie.

Page 2 - 13 is the **Monthly Detail Report**, which provides more information regarding each gift, using the same definitions as above, showing where and how the donor has designated their gift to be disbursed once it is received.

Page 14 is a list of congregations designated by donors in 2018 to receive either current or future gifts.

With **14 gifts** in the fourth quarter totaling **\$1,871,350**, the YTD Total has reached **\$7,507,500**, with **\$934,500 already received this year, and disbursed to the beneficiaries**. May God be praised!

Page 15 is a summary of the gifts planned or received over the last ten (10) years, since formalized reporting on the Foundation's activities to a wider audience was undertaken. The allocated amounts reflect the direct wishes of the donors themselves.

Gift Coordinators work on behalf of all LCC organizations equally, promoting, encouraging, assisting, stewarding, and managing the development of planned (estate) gifts or significant lifetime gifts as part of a Christian's overall stewardship plan. It has been our experience that donors are excited about the opportunity to create a gift within their estate, supporting a ministry to which they have a passion.
